




N April 3, 1917, a special meeting of the directors was held in Chicago. Present: Messrs. Wilson, Hilton, King, Thomson, Linn and

Dickinson. The following events for the season of 1916 were arranged:

CLUB CHAMPIONSHIP

Four races will be sailed for the Club Championship, as follows:

Thursday p. m.		-	August 16th
Saturday a.m.	-	-	August 18th
Tuesday p. m.	-		August 21st
Thursday a.m.	-	-	August 23rd

All four races are to be sailed and counted for the championship if possible; if it is necessary to call off any race, the remaining three races shall be sailed and counted for the championship. If more than one scheduled race shall be called off, the regatta committee will arrange additional races until three races shall have been sailed, and these shall be counted for the championship. The point system of scoring shall be continued—a boat being credited with a point for each boat it defeats in

each race, and the winner of the largest number of points being awarded the Club Championship Trophy for 1917. A second prize shall be awarded to the boat having the second largest number of points.

TEAM CUP

This perpetual trophy having been won twice by the Chicago Club, will again be sailed for during the present Regatta to determine the holder for the season of 1917. On the day preceding the opening of the Regatta, a committee of club members from each resort shall hand to the Commodore a list of three boats, owned by members of the club from their respective resorts, which shall constitute their team. The team of three boats having the largest sum total of points won during all the championship races of the Club Regatta shall be awarded the team trophy, and they shall have the custody of the trophy for one year.

Should any boat, constituting a unit of one of the two teams, be disabled during the Regatta, another boat may be substituted, but the substitution must be made before the start of any one race.

YACHTS ELIGIBLE

Any sailing yacht, owned by a member of the Club, not exceeding thirty feet over all, of the type known as displacement boats, shall be eligible to all of the above events.

FREE-FOR-ALL SAILING RACE

This race, this year, will be an innovation. A special cup will be presented to the winner of two races by the point system, from Charlevoix to Harbor Point and from Harbor Point to Charlevoix. The entries will be handicapped, and all details arranged and announced by the Regatta Committee. It is hoped that a long race in the open waters of Lake Michigan will call out many entries.

MOTOR BOAT RACE

The motor boat race this season will be a handicap event. The details will be arranged and announced by the Regatta Committee. Mr. Logan Thomson has been elected official motor boat handicapper. Suitable prizes will be presented by the Club.

SAILING RULES

It is desired to call the attention of members to the official sailing rules adopted by the Club, being those given in the "Handbook on American Yacht Racing Rules, "by H. DeB. Parsens. Copies may be had of the Rudder Publishing Co., 254 West 34th St., New York.

1916 ANNUAL MEETING

The meeting was held on board the flagship "Penguin," August 26, 1916, pursuant to notice.

There were present Commodore John P. Wilson, Jr., Mrs. Lane, Miss Clara Bailey, and Messrs. Hilton, Roemler, King, Douglas and Dickinson.

The meeting was called to order by Commodore Wilson.

In the absence of the Secretary, Mr. Douglas was appointed Secretary pro tem.

On motion duly made and seconded, the reading of the minutes of the last meeting was dispensed with.

In the absence of the Treasurer, Mr. Roemler read the report of the Treasurer, which had been forwarded to him.

On motion duly made and seconded, the Treasurer's report was approved and ordered placed on file.

After discussion, on motion duly made and seconded, it was resolved not to hold a bang-and-go-back race next year.

The report of the Regatta Committee as to the series of races just concluded was received, and in accordance therewith the first place was awarded to the "Whistlewing II," the "Cynthia" took second place, the "Froyda" being third.

The meeting then proceeded to the election of officers. The present officers were re-nominated for their respective offices, with the exception that W. Scott Linn was nominated for Treasurer only, and William R. Dickinson for Secretary.

The nominations being closed, on motion duly made and seconded, the Secretary was directed to cast the ballot of the meeting in favor of the nominees. The ballot was cast and the present officers, with the exceptions and additions indicated above, were duly elected.

The present members of the Board of Directors, with the exception of Miss Clara Bailey, were then nominated for re-election, and Logan Thomson was nominated as director in place of Miss Bailey.

The nominations being closed, on motion duly made and seconded, the Secretary was directed to cast the ballot of the meeting for each of the present directors, with the exception of Miss Bailey, and for Mr. Logan Thomson for the year 1917. The ballot was cast and the nominees were duly declared elected.

After being duly nominated, upon motion duly made and seconded, Messrs. Hilton, Roemler and King were duly elected as the Regatta Committee for the following year.

The meeting adjourned.
